Selection Procedure for the position senior researcher

The Dean of the Hussite Theological Faculty of Charles University (HTF UK) announces the selection procedure for the position of a **senior researcher – within the project Call No. 02_18_053 Mezinárodní mobilita výzkumných, technických a administrativních pracovníků výzkumných organizací v prioritní ose 2 OP VVV (MŠMT)**. (International mobility of researchers, technical and administrative workers of research organizations in the priority axis 2 OP VVV). Title of the project: Mezinárodní mobilita výzkumných, technických a administrativních pracovníků na Univerzitě Karlově. (International mobility of researchers, technical and administrative workers of Charles University).

We offer:

- Participation in the Charles University project as part of the challenge of OP VVV No. 02_18_053 Mezinárodní mobilita výzkumných, technických a administrativních pracovníků na UK (International mobility of researchers, technical and administrative workers of Charles University) (MŠMT ČR).
- Mobility workplace: Prague, The Hussite Theological Faculty, Charles University.
- Workload 1.0.
- Duration of the project: 3 months, family project support will not be provided for staff members.
- Mobility focus: Migrace a budoucí náboženská mapa Evropy: Etické, společenské důsledky a náboženské determinanty (Migration and the future religious map of Europe: Ethical, social consequences and religious determinants).
- As a part of the project, the researcher is obliged to participate in 1 conference/seminar/workshop etc. organized by the hosting institution.
- Any potential research outputs generated during the mobility must be published in the form of Open Access.
- The beginning of mobility: August 2020 - September 15, 2020.

Requirements of the tenderer:

- The university academic/research worker has been employed by an organization/organizations outside of Czech Republic in the past 3 years for at least 2 years in the area of research, with an employment contract of at least 50% (half-time employment) for the entire duration of the contract.
- An obtained title of Ph.D./Th.D. (or equivalent, ISCED level 8 equivalent) in the field of Theology 7 or more years ago.

- Participation in at least one international grant or national grant over the last 5 years as a solver or co-solver.
- Publication activity – at least 3 publications within the last 5 years (i.e. academic publications indexed in the scientific databases Thomson Reuters' Web of Science, Scopus or ERIH PLUS, belonging to one of the following categories: "article," "book," "book chapter," "letter," and "review").

The tenderer will supply:

- A filled out application form.
- A professional curriculum vitae (with a list of grants in which he/she has been involved).
- A list of scientific publishing activities.
- A copy of the highest education diploma or completed higher education degrees.
- Mobility content: a brief description of the intended research corresponding to the focus of mobility, involvement in the research team, the contribution of worker's mobility to his/her development and the development of subjects taught by him/her, mobility objectives and, research timetable (2 – 3 pages).

The mobility course is subject to the rules for applicants and recipients, specifically, the challenge of International Mobility of Researchers (OP VVV No. 02_18_053).

Site and deadline for placing the application: Applicants are to send their applications along with the required accompanying documents in electronic form in Czech, Slovak, or English language to: barbora.galova@htf.cuni.cz. Write „SP Mobility“ into the subject field of the message.

The deadline for submitting applications and related documents for the selection procedure: **July 17, 2020, 6.00 p. m.** (Central European Time).
